To Parents and Guardians:

The Immaculate Conception School Board, Finance Council, and Fr. Robert have finalized tuition rates for the 2019-2020 school year. Please know that we strive to keep increases to a minimum while addressing rising costs in salaries and other expenses, and keeping our educator to student ratio at a level that enhances learning. In preparation for this year's budget development, we did a thorough comparative analysis of the tuition, fees and any required fundraising hours or dollars of 11 other Catholic schools on the northwest side. We will continue to work vigorously to provide you and your student with the exceptional education you expect and deserve for your investment dollar at IC.

- **Markets the school:** Promoting the excellent education and vibrant family community present here at IC is the best way to make sure we have strong enrollment into the future.
